NOMINATION OF CANDIDATES BY REGISTERED POLITICAL PARTIES

Each nomination **MUST** be accompanied by:

(Please tick ✓)

- \$200 (for each endorsed candidate). Payment may be made in CASH OR BANK CHEQUE (NOT personal cheque), made payable to the Receiver of Territory Monies (RTM).
- A photograph of each candidate:
- (i) black and white, full faced, vertical, portrait photograph of the candidate's head and shoulders
 - (ii) taken within six (6) months of lodging the nomination and
 - (iii) endorsed on its reverse side, the full name of the candidate and a statement signed by him/her certifying that the photograph was taken within the previous six (6) months (Reg 3)

However, the Electoral Commission may accept a photograph of a nominee that does not comply with the above, if the Commission is satisfied the nominee is readily recognisable in the photograph.

This form **MUST** also include:

(Please tick ✓)

- A listing of the persons endorsed as candidates by the party, with the Legislative Assembly Division adjacent to their names and signed by the Registered Officer of the Party (*Section 1*).
- A consent to stand signed by each candidate, which includes any request regarding the form of their name to appear on the ballot paper, and their individual declarations of eligibility (*Sections 2,3,4,5*).

Lodging the nomination form:

The nomination form, deposit and photo must be lodged during business hours after the close of rolls and **before 12 noon SHARP nomination day**. See NTEC website for key dates and timetable

As the lodgement period is limited, those lodging nominations are strongly encouraged to make an appointment with an officer authorised to receive nominations at an appointed location for that purpose, which includes the Commission offices in Darwin Phone: (08) **8999 7613** or Alice Springs (08) **8951 5975**.

The nomination can be lodged in person or by fax (08) 8999 7630. Other means may be acceptable after discussion with an officer authorised to receive nominations. If nomination forms are faxed, your photo should be lodged in person or by email (*remember to also forward the endorsement with the email or on the back of the photo*) to an officer authorised to receive nominations. The deposit of \$200 for each endorsed candidate **MUST** be lodged in person. Those lodging nominations are strongly advised to confirm receipt of nominations if not delivered in person. **DO NOT LEAVE LODGEMENT TO THE LAST MINUTE AS LATE NOMINATIONS WILL NOT BE ACCEPTED.** Remember, the onus is on those lodging nominations to ensure they are received by the nomination deadline.

Note:

- Eligibility criteria are prescribed in the *Northern Territory (Self-Government) Act 1978* ss20, 21(1) and are covered in the declaration contained in section 2(c) on this form.
- The NTEC is collecting the information on this form to process nominations as required by the *Electoral Act* s32. The names and affiliations of candidates are publicly declared as soon as practicable after the close of nominations (*Electoral Act* s37).
- With the candidates consent, certain other contact details will be provided to the media and the public and be published on the NTEC website. Candidates seeking public office usually find wide dissemination of this information desirable.

- am not entitled to any remuneration or allowance (other than reimbursement of reasonable expenses) in respect of that office, appointment or employment;
- am not an undischarged bankrupt;
- have not been convicted and am not serving one or more year's term of imprisonment for an offence against the law of the Commonwealth or of a State or Territory.
