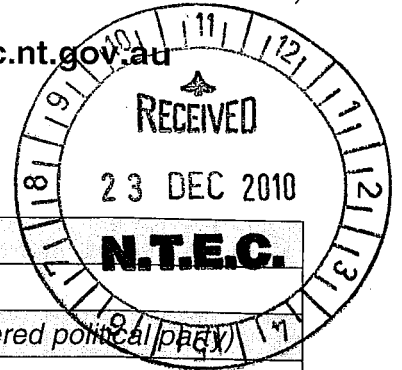

Who completes this part?	– All candidates
