Scrutineer rights, responsibilities and rules

****Scrutineers must wear the vest and ID tag provided by the NT Electoral Commission.****

Number of scrutineers permitted

Voting centres

Only one scrutineer representing a particular candidate is entitled to be present at a voting centre at any given time during voting hours. A scrutineer is permitted to leave and return to a voting centre without re-submitting an appointment form, but must return the scrutineer vest and ID tag to the voting centre manager upon exiting. A scrutineer's place may be taken by another appointed scrutineer.

Scrutiny centres

One scrutineer representing a particular candidate per count table is entitled to be present at a scrutiny during the conduct of the count. A scrutineer is permitted to leave and return to a voting centre without re-submitting an appointment form, with the exemption of election night counts at a voting centre where the doors are locked and scrutineers cannot re-enter. Scrutineers must return the scrutineer vest and ID tag to the scrutiny centre's reception upon exiting. A scrutineer's place may be taken by another appointed scrutineer.

What a scrutineer can and cannot do

A scrutineer CAN:

- observe voting in any voting centre, including the questioning by issuing officers to voters – except the voter actually voting (unless nominated to assist by a voter or requested to witness assistance being given by a voting centre manager)
- be nominated by a voter to assist them to complete their ballot paper/s
- object to the right of any person to vote - the objection will be noted, although the voting centre manager may still allow the person to vote
- witness the sealing and unsealing of ballot boxes at a voting centre or scrutiny centre
- enter and leave the voting/scrutiny centre at any time during voting/counting but must return the scrutineer vest and ID tag upon exiting, even if they plan to re-enter (noting a scrutineer's place may be taken by another appointed scrutineer)
- inspect, but not touch, any ballot paper at the count.

A scrutineer CANNOT:

- stay in a voting centre without submitting a completed appointment form to the voting centre manager
- scrutineer at a voting centre or scrutiny centre without a scrutineer vest or identification tag
- touch ballot papers
- position themselves in a way that they have a view of any voter marking their ballot paper/s
- go near the voting screens; except to provide assistance to a voter to mark their ballot paper where nominated or to witness such assistance being provided by a voting centre manager to a voter
- interfere with a voter, or attempt to influence them
- reveal anything they know about how an elector has voted
- wear or show campaign emblems, t-shirts, badges or similar inside the voting centre
- use an image recording device (i.e. mobile phone, camera or video recorder) in a voting centre or scrutiny centre
- show, hand out, leave or remove campaign material in or from the voting centre
- communicate with any person in a voting centre other than in the exercise of their functions as a scrutineer
- help with clearing voting screens or the removal of material from a voting centre
- assist with the sorting or counting of ballot papers.
- talk to voting staff or count staff who are not managers or supervisors.

Please discuss any queries or objections about procedures with the voting centre manager or scrutineer coordinator at a scrutiny centre. Scrutineers must respond to any lawful direction from the voting centre manager.
